

One of my daughters admitted to going to the bathroom to meet her other friend there so they could watch a funny video on YouTube. I have no idea what sort of parent controls are/are not on her friends' phones. The lure is so strong with these devices - they are such a huge distraction to all the other good work happening at school.
