



1. What grade level(s) do you work with? (check all that apply)






2. How long have you been working in the Revelstoke school district?







3. How well do you know and understand your school's expectations on student use of personal digital devices?




4. Which personal digital device(s) do you see student's using in your classroom? (check all that apply)



5. How often are students given permission to use their personal digital devices in your classroom(s)?




6. How often do you see students use personal digital devices in the classroom without teacher permission?




7. For what purpose do students use personal digital devices in the classroom? (check all that apply)





8. On a scale of 1 to 5, in your classroom(s) how disruptive do you find student use of personal digital devices?





<b>1</b>	anonymous	All of the aforementioned are constant issues in the classroom. With relationships the response to putting the device away improves but the distraction is constant. It's addictive. We must commit to a stronger educational approach that marries restrictive policies.
2	anonymous	I think there would be many challenges if students used their devices in the elementary setting. I am very thankful phones are not allowed on school property!
3	anonymous	Students automatically go on their phones when they do not know what to do next, even when other options are supplied. There is a big addiction to cell phone use. Students no longer look for other options that would be more beneficial to their learning, growth, and mental health.
4	anonymous	Many students have difficulty knowing appropriate times to use their personal devices and often will want to use them when not appropriate. This leads to a potential of conflict with staff and a disruption to the class as well as using teacher time and

		resources to manage. Secondly, personal devices when on or close to a student becomes distracting to them because they may be either anticipating a message/notification or wanting to send/respond to one.
5	anonymous	Status seeking, disruptive, inappropriate content, bullying via the device, social issues I then need to solve, it gets lost and I'm the one supposed to find it
6	anonymous	These devices in the classroom take up a large amount of time in enforcing use. Many students refuse to put them in the phone hotels and while a couple of times I have wrested them out of students' hands, this is not a battle that I wish nor should be engaging in, especially with students who bigger, stronger, and taller than I am. They are so addicted to these devices, they don't even realize sometimes when they pull them out of their pockets, bags to use them. At any lull in teaching, working, etc., they take them out, and when I see them, they either put them back and say it won't happen again (of course it does), refuse to put them back or ignore me completely. Not all, of course, but monitoring these devices take up far too much classroom time and energy And yes, there's a gender difference: some students will put their phones in the phone hotels when asked to by a male teacher, but not by a female teacher. I could send students to the office for not complying, but that's not how I want to set up my classes. Next year, however, if the policy is not changed, I will start doing that if students do not put them in the phone hotels as soon as entering class. It also sets up inequalities among students. Some students can function and get their work done while listening to music on their phones, but when I give one student this opportunity, it creates issues with those who can't. A no-cell-phone policy from admin NOT at the discretion of the teacher takes away this issue for everyone.
