JODIE ALLEN

"Last week, I had a unique task: to create a job description for an Indigenous Liaison Officer. This position had been filled by a contractor for the past two years, but with their departure, we decided to bring it in-house and make it part of the bargaining unit." I learnt that for Indigenous specific roles, we must recognize that traditional hiring practices may not reflect Indigenous values or experiences and that we must adapt the process to ensure it's culturally safe and inclusive – the goal is to remove as many barriers as possible. "This process not only helped me develop the job description but also challenged me to think critically about how we can make hiring practices more inclusive across the board. It was an eye-opening experience, and I am grateful for the guidance I received."

Trustees also acknowledged the passing of Linda Nicholson who was a gifted educator and who encouraged many young students to pursue teaching as their profession.

- A) Superintendent's Administration Report to the Board

Jodi Wallach presented the Superintendent's Administration Report highlighting:

- Community partner engagement parent caregiver series (4 sessions) teen sexual health was one of the best attended sessions so far in the series. Hannah Beach is the next session presenter who has been highly anticipated.
- Jodi Wallach has been working on the audit this week, it has been an interesting process where staff are learning and finding ways to improve on in the future.

B) Superintendent's Strategic Plan Report to the Board.

Jodi Wallach presented the Superintendent's Strategic Plan Report for the Board

- Roberta visited RSS to meet with Sarah Vincent and Mary Catherine LaForest who
 presented to staff on student voice, discussed eloping from class (withdrawing or
 leaving class sometimes voluntarily or involuntarily) and ran an activity with staff on
 how to ask questions to help students and reimagine what their classrooms could
 look like. (Question will street data be added to the website so that it is accessible
 to the parents and guardians).
- Susan Leslie has given 2 keynote speeches on Indigenous Knowing and Ways of Being. Meghan Doebert, Kindergarten teacher at BVE, has continued to meet with Susan to work to embed the Indigenous Ways of Knowing and Being into Early Learning through Numeracy circles.
- C) Superintendent's Memo to the Board Draft Restriction of Personal Digital Device Policy for Final Reading

The Policy Committee has requested the Superintendent inform the students and staff that that the policy will be rolled-out after spring break.

D) Superintendent's Memo to the Board – How Are We Doing Report (HAWD)

 - The successful contractor (TKI Construction Ltd.) has been selected.
 - The planning process will start once a letter of intent has been sent to the successful contractor.
- B) MOECC Final Funding Verbal Update

Mid-December is when the final funding is usually announced but that has been delayed until the end of January. There have been no dates provided so far for the extension of amended budget submissions, so the deadline is still February 28th. If the deadline is not changed a special Board meeting may be required to adopt the amended budget.

C) Compliance Audit Verbal Update

The compliance audit is done by the ministry, they are looking to make sure that the district is supporting the students with the money that they are claiming. They are looking for documentation to ensure that students are receiving cultural and academic supports are being claimed. Jodi Wallach has exceeded expectations during this process and the district thanks her for her dedication.

SEY2KT (Strengthening Early Years to Kindergarten Transitions)

This is the first year of SEY2KT in Revelstoke! Our wonderful SEY2KT team consists of 21 members from the school district and community. The focus of SEY2KT is around creating seamless transitions for children and families through strengthening relationships and connections between community partners and educators in the two systems.

Our SEY2KT journey began by coming together and brainstorming around the current reality, as well as our hopes and dreams, for kindergarten transitions. 3 key themes emerged:

- Facilitating smooth transitions to kindergarten
- Strengthening relationships between ECEs and kindergarten teachers
- Increasing awareness of the importance of early childhood experiences.
 We put our heads back together and came up with 3 action items for the current school year.

Pre-K Play!

Revelstoke children coming to Kindergarten in September 2025 are invited to visit their neighbourhood Kindergarten classroom for a play in the K from 4-5pm on Feb 27th, April 24th, May 29th! All 3 schools will open their doors on these days to:

- Play and explore
- Meet a Kindergarten teacher
- Meet neighbourhood families
- Ask questions

Childcare/preschools visiting K classrooms (during school hours)

Ten community childcare/preschool centers are participating in all 3 elementary schools. This is part of an effort to help foster strong connections and provide valuable opportunities for all children in our community. These visits will give the younger children a chance to experience what kindergarten is like, while allowing our kindergarteners to model their learning and share their experiences with the younger students. It's a wonderful opportunity to promote a sense of leadership, community, and kindness within our classroom.

Earlier K registration (October)

Move Kindergarten registration to earlier in the year, which gives us all the gift of time, allowing us to connect with families and get to know children who will be coming to Kindergarten.

Lastly, we are breathing some life back into the meaning of "every door is the right door" by hosting a SEY2KT gathering/sharing event on Feb. 20th. This is an opportunity for the SEY2KT team and early years community to learn about the wonderful work we all do, ask questions, and connect. Much gratitude to Vice Principal Naomi Ford for leading this initiative in her new role.
