2024/2025 Audited Financial Statements

Board Chair Chell introduced Madison Attwood, partner with BDO. Ms. Attwood met early with the Board at the Board's Finance and Facilities meeting and presented the 2024/2025 Financial Statements, noting that the 2024/2025 Financial Statements are materially correct and comply with the Accountability Act. This was a clean audit with the district following the accounting standards. The presentation focused on Statements 1 and 2. RTA president asked for clarification regarding the district's surplus with clarification being provided.

- The District is aligned with the District Strategic Plan, to ensure the well-being of students Mental Health
- Pathways Initiatives Universal design for Inclusion and Indigenous Informed Pedagogy were highlighted plus lead teachers that are involved with these pathways

• Further alignment continues on the Framework for Enhancing Student Learning, Strategic Plan beliefs, learning focus, and pathways

It was noted that it's impressive as to the number of teachers taking on leadership rolls.
