SUPERINTENDENT KUBIK

Administration Report to the Board

Superintendent Kubik presented her Administration Report to the Board highlighting school visits: AHE – check in with a teacher who sits on the professional development committee in support of an AI conference, BVE – attended an appreciation event to recognize the work of Education Assistants, RSS – joined the Leadership students along with the Indigenous Leadership students, together they planned the assembly and activities honouring Truth and Reconciliation.

Strategic Plan Report to the Board

Superintendent Kubik highlighted three areas of the Strategic Plan: Intellectual Development, Numeracy and Literacy, Human and Social Development, noting that provincial data indicates that this district is above the provincial average in these areas; and transition rates to BC post-secondary institutions is lower than provincial average. Students attending post-secondary in Alberta are not included in the count. Questions were asked and answered.

Superintendent R. Kubik presented the Interim Enhancing Student Learning Summary noting Intellectual Development, Human and Social Development, and Career Development. It was recommended that the Board approve the Interim Enhancing Student Learning Report as presented.
